Train Race Rules

General Rules:

- Driver must be 12 years or older
- Drivers 18 years and younger MUST have a parental Authorization Form signed
NO EXCEPTIONS!!
- The train will consist of 1 full size car or pickups the Engine and 2 small size cars, 1 as the passenger car and the other as the caboose.
- Must be ½ ton or ¾ ton pickup, no 1 ton or dualies
- The train must be connected and operational at the finish of the race to be scored.

Car & Truck Body Requirements:

- Pickup trucks MUST be stock and 2-wheel drive. Can use a 4x4 but NO front drive shaft.
- Must have 7" wheels and no tires over 235-75/15 or 9.50-16 NO EXCEPTIONS!!
- No lift kits
- No split rims
- Full size cars MUST be stock!!!
- 114" wheel base or larger 7" wheels and not tire over 235-75/15 DOT approved
- All head lights and tail lights must be removed
- Hancock County Fair Full-size Demo Car rules apply!!

Small Cars:

- Any compact or midsize car can be used. This car may or may not run
- The caboose car MUST have breaks and MUST have working seatbelts
- Batteries must be removed from rear vehicles
- All cars MUST be stock!!
- The motor and transmission must be in both rear vehicles
- All head lights and tail lights must be removed
- Hancock County Fair Small Demo Car rules Apply!!

Connection of the train:

- Chain MUST be used to connect the cars
- The chain from the engine to the passenger car must be 3 feet from bumper to bumper
- The chain from the passenger car to the caboose must be 4 feet from bumper to bumper
- No reinforcement of any kind
- Chains can be mounted any way

Safety Rules:

- All drivers must have a helmet
- All drivers must have working seat belt on at all times while on the track.
- Window nets are required for driver's door of front and rear vehicles.
- Racing fire suit recommended with gloves and neck brace Recommended Only!
