2. The committee/ coordinator reserves the right to cancel any or all future reservations made by an exhibitor acting in any manner deemed to be inappropriate.
3. Exhibitors must be present and set up during all hours open to the public. Your deposit check will be returned to you on Sunday at the release time.

**Set up:**

**Monday July 25<sup>th</sup>: 4pm - 8pm or Tuesday July 26<sup>th</sup>: 12pm to 4pm**

**Tear down will be at 4:30pm on Sunday July 31<sup>st</sup> when we are released from the building.**

4. All canopies, tables and display materials will be provided by the crafter. Table covers are required.
5. Sales Tax: It is the responsibility of the vendor to collect Iowa State sales tax and remit to the Iowa Department of Revenue and Finance. If you do not have an Iowa Sales Tax permit you must go to the Dept. of Revenue to obtain one. They no longer give out temp. Permits.
6. We are allowing hand-crafted items, home based businesses. NO Flea Market/carnival type items. NO silly string, potato guns, snaps, or any kind of toy guns. NO food or beverages to be sold.
7. NO refunds for cancelations.
8. Spaces are assigned by discretion of the Fair Board.
9. 110-volt Electrical outlets are available.
